## SHOW SITE / Trial Information

- Follow Parking Rules and Directions
- Dogs requiring measurement should be measured prior to their first run. Dogs with a wither height of 20" or less will need to be measured unless they have a permanent AKC, NADAC or ASCA height card
- Trial equipment as follows: Rubberized, slatted A-frame (adjustable, pre-set at 5' 3") and dog-walk, rubberized teeter – slat-less, wing jumps, non-wing jumps, displaceable tire, tunnels, double jump, weave poles 24" spacing.

- Lunch will not be provided for workers.

- Entries postmarked before the opening date of Monday, May 18, 2026 - WILL NOT BE ACCEPTED.
- Entries will be accepted by order of postmark.
- Entries must be received by the closing date of Saturday, June 20, 2026.
- Entries cannot be canceled after the closing date.
- Pre-entries will be accepted after closing date for a \$10 surcharge – if trial is not full.
- Entries are limited to a maximum of 350 runs per day.
- ALL dogs (including Novice) may or may not have a ASCA Dog Registration number or ASCA QTracking number when entering this trial.
- Entries will be accepted for dogs entering using “pending” in lieu of a number. Please see the ASCA website for information on how to register.

- Do not mail your entries by any method that requires a signature.
- Entries must be submitted on the forms or copies of the forms supplied in this premium.

- No entry shall be accepted from a dog or handler disqualified from the ASCA agility program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.

**The existing ASCA program has been renamed the Championship Program. The CH program consists of the traditional three divisions, Standard, Veterans and Junior Handler. Dogs will earn the same ASCA titles as before, and qualify for Merit, Finals, and HOF programs. The NEW ACE PROGRAM: For standard dogs (18 months & older) that want to run at the next lower jump height and earn the ASCA ACE titles. Effective January 2015, the ACE program will include the Sr. Dog Division for dogs 10 and older. Each dog and handler team can only enter one “program” per trial.**

### Toys in the Ring

We will be permitting handlers to have toys in the ring at this trial. Toy runs will run in order in their jump height. For details, please refer to Section 9.1 of the most recent rulebook available at <https://asca.org/wp-content/uploads/2022/08/agilityrules.pdf>

### REFUNDS

There shall be no refunds for entries withdrawn in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal. Refunds are allowed if requested before the closing date. Refunds after closing date for bitches in season only. **ALL REQUESTS FOR REFUNDS MUST INCLUDE OWNER’S NAME AND ADDRESS AND VETERINARIAN’S CERTIFICATE.**

### MOVE-UPS

After submitting your entry form, the last day that we will be accepting move ups before the trial will be Monday, June 22, 2026. Move-ups will be allowed during the trial in person within 15 minutes of last run, on Saturday. Move up form will be available at score table.

### AWARDS

First through fourth place ribbons will be awarded for each jump height in all classes and levels. Qualifying Rosettes will be awarded for each qualifying run.

## JUMP HEIGHTS

Dog’s Height	11” & under	14” & under	18” & under	20” & under	Over 20”
CH-Standard jumps at:	8”	12”	16”	20”	20” or 24”
Vets & Ace Std. jump at:	4”	8”	12”	16”	16”
ACE Sr. jumps at:	4”	4”	8”	12”	12”

ASCA height rules allow dog in 20+ category (measuring over 20” at withers) to jump in either the 20+ or 24” jump height class if offered. Veterans must jump 4” lower than the dog’s standard jump height and Junior Handlers may jump 4” lower than standard, OR at the dog’s standard jump height. Dogs with a wither height of <20” must be measured (or show an approved jump height card) unless they jump in the 20+ / 24” class. (16+ for veterans, ACE Std.).

**CH – STD 8” 12” 16” 20” 20+” (jumps 20”) 24”**  
**JrH may jump at the standard jump height or 4” lower**  
**Vets & Ace 4” 8” 12” 16” 16+” (jumps 16”)**

- ◆ **A dog may be entered in a class at a jump height higher than they are eligible provided the dog is not entered in the Veteran Division classes.**
- ◆ **No dog shall ever jump lower than 4” in the Junior Handler or Veteran Division.**
- ◆ **20+ and 24 will be scored and placed together as one class.**
- ◆ **Refer to the current ASCA rule book for the current Breed Jump Height Exemption List.**

## NOTICE TO EXHIBITORS

This trial is sanctioned by the Australian Shepherd Club of America, with The Hudson River Australian Shepherd Club of New York as the sponsor club. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations, and agree to abide by all rules in effect at the time of this trial.

- ◆ All healthy, trained dogs over eighteen (18) months of age are eligible to compete in ASCA agility trials. Dogs entering in ANY level of classes do NOT have to have an ASCA registration or QTracking number. Application for QTracking number can be obtained at: <https://www.asca.org/wp-content/uploads/2022/06/qtsvcapp.pdf>.
- ◆ Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity, which may cause a judge to not be able to reasonably assess the dog’s ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- ◆ Any dog which demonstrates aggression towards any person or any dog, whether inside the ring or outside the ring, must be excused from the agility trial. Any dog which the judge feels is not in enough control to perform all obstacles in a safe manner will be excused from the agility trial.
- ◆ This ASCA agility trial shall be open to purebred and mixed breed dogs.
- ◆ No bitches in heat allowed on grounds.
- ◆ No collars, food, toys (exception is for those who declare they are running with a toy), clickers, or other aids or devices shall be permitted on the course or within ten feet of the ring entrance at any time. The only exception to this is leading your dog to the start on lead, and then handing the lead to a steward. All dogs should be on leash or in a crate or pen when not competing.
- ◆ Safety shall always be the foremost consideration in actions and conduct by handlers at all times. The organizing committee may NOT refuse any entry other than on the basis expressly provided through rules and regulations of the sanctioning organization(s). Anyone not currently in good standing with ASCA will not be allowed entry into the trial.

The sponsoring club will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause. It is distinctly understood that every dog at this event is in the care, custody and control of his owner or handler during the entire time the dog is on the show premises. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial/Show Committee, be asked to leave the show site. In such case, no refund of fees paid will be made.

**FROM THE NORTH:** Take 87 (Northway) south to exit 15. Turn right at the top of the exit ramp and head toward Saratoga Springs on Rt. 50 South. Continue on Route 50/9 for 2.4 miles, bearing right to stay on 50. Van Dam St. becomes Church St. (9N) out of Saratoga Springs. You will go past the Saratoga Hospital on the right, past a medical complex. Continue for approximately 5 miles. You will eventually come to the little village of Greenfield Center. At the stoplight, turn left onto South Greenfield Rd. Go up a little hill, down the hill and then on the right you'll see yellow arrow signs, the driveway for Jazz is just past those signs. **AGREEMENT**

**IMPORTANT LEGAL AGREEMENT**—Please read the following carefully as it, among other things, may prevent you from suing ASCA® and persons/entities affiliated with it. This agreement could even require you to defend them from demands and suits by third parties that include an assertion of wrongdoing by you. (1) The person signing this Agreement represents being authorized to enter into it on behalf of him/herself, as well as (if different) the owner(s)/exhibitor(s)/handler(s) of the dog(s) for which an entry form is being submitted (all these parties collectively referred to herein as "Applicant"). (2) "Releasees" here collectively refers to the Australian Shepherd Club of America® (ASCA®); its affiliate clubs; and the officers and board of directors, staff, contractors, insurers, attorneys, and agents of ASCA® and of those clubs. (3) This Agreement voluntarily is entered into by Applicant in exchange for the acceptance of the associated entry form and permission to participate in related activities. (4) Applicant agrees to abide by the rules and regulations of ASCA® and any other rules and regulations applicable to this event. (5) Applicant certifies that the entered dog will not pose a hazard to people, property, stock animals, or other dogs, and further that the dog is current with rabies shots along with any other vaccinations required by its state of residence. (6) Applicant acknowledges and assumes the risks to Applicant and Applicant's dog associated with participation in the event, among which could be ones associated with poor condition of the facilities and surrounding areas; security measures or lack of them; electrical appliances; fittings; show rings; the presence of unfamiliar persons; and the presence/involvement of other animals—whether stock, dogs, or otherwise. (7) Applicant further agrees to comply with all recommended and required health and safety precautions, among which may be those related to social distancing; quarantining; wearing of face coverings; and non-participation of persons exhibiting symptoms or for whom there otherwise has been a likelihood of recent exposure to COVID-19 or other contagious diseases. (8) Applicant additionally acknowledges and agrees to assume the risks associated with taking part in the event though others might neglect compliance with health and safety precautions/requirements or pose an undue risk of spreading disease. For example, as is true as to any public event, there is some risk that Applicant and/or those affiliated with Applicant may catch COVID-19 or another contagious disease at the event. (9) To the maximum extent permissible, this release is to be interpreted under Texas law, without application of its choice of law rules. (10) To the extent that Applicant—or another party suing on behalf of Applicant, or suing to recover based on injuries/death/damage to Applicant/Applicant's dog/Applicant's property—sues ASCA® (or a board member or staff member or agent of ASCA®) as a defendant, the sole appropriate forum (to the maximum extent permitted by law) for the suit shall be the state or federal courts serving Brazos County, Texas (where ASCA® has its headquarters). (11) Applicant hereby releases and waives any claims Applicant otherwise might assert against the Releasees as to any injury or damage claim connected in any way to any alleged act or omission arising out of, or occurring concurrent with, the event and related activities, interactions, communications, and even adjacent premises. (12) This release is made not only as to Applicant but also for anyone who might assert a claim on behalf of Applicant or based on purported injury or damage to Applicant/Applicant's dog/Applicant's property, as well as any heir, beneficiary, assignee, executor, trustee, agent, or survivor of Applicant. (13) Applicant further agrees to assume sole responsibility for and indemnify and hold Releasees harmless from related claims, demands, judgments, and settlement payments. (14) These waiver, release, and indemnification provisions extend even to claims or demands asserting that the acts or omissions resulted in bodily injury or death or from intentional wrongdoing, as well as to attorney fees and other costs of defense. (15) The duties of indemnification further extend to any claims or demands asserted against Releasees that are alleged to have arisen out of the acts or omissions of Applicant, Applicant's dog, or others affiliated with Applicant. Among other things, this means that Applicant would pay the legal defense of Releasees if someone sued them based on a claim Applicant carelessly exposed the claimant to COVID-19. (16) Applicant's promises in this agreement apply without regard to the type of claim or cause of action asserted against Releasees. (17) To the extent any provision of this agreement is unenforceable, the remainder of it nonetheless is to be enforced. (18) This agreement is to be interpreted to provide Releasees with the maximum permissible legal protection from—among other things—claims and suits pursued by Applicant (and/or those acting on behalf of Applicant or over injury/damage to Applicant), as well as from ones based on the purported wrongful acts or omissions of Applicant. (19) Nothing in this Agreement requires you to indemnify Releasees from claims by third parties that involve no allegations of improper acts or omissions by you, those affiliated with you, nor your dog(s). (20) Applicant acknowledges having read, understood, and had the opportunity for independent legal review of this document prior to signing it.
